(Minimum annual contribution is \$120 and the current maximum is \$3,050*) Note: health insurance premiums do not qualify for reimbursement. *The Flexible Employees' Benefits Board provides a \$50 credit to any member who enrolls in the HCRA. <p style="text-align: center;">Important – Read Carefully Before Signing</p> <p>I understand that I cannot change or revoke any of my elections at any time during the plan year (Jan. 1-Dec. 31) unless I have a change in status as defined by the IRS. During the annual open enrollment period, I will be given the opportunity to enroll in the plan for the upcoming plan year (Jan. 1-Dec. 31). I must enroll each year during the open enrollment period since participation in the plan for subsequent years is not automatic, even if I want to contribute the same amount as the previous year. Up to \$610 of unused funds remaining in the HCRA will "carry over" to the 2024 plan year after the 2023 filing period has expired, provided I re-enroll in the HCRA for the 2024 plan year. If I do not re-enroll for the 2024 plan year, all funds remaining in the HCRA after the 2023 filing period has expired will be forfeited. Even if I do re-enroll for the 2024 plan year, funds in excess of \$610 remaining in the HCRA after the 2023 filing period has expired will be forfeited. Unused funds remaining in the DCRA are forfeited after the 2023 filing period has expired.</p> <p>I further understand and agree that if I receive payments that exceed the amount of eligible expenses or if I fail to provide proper documentation for a request for reimbursement or validation of a debit card transaction, I will be required to repay the excess reimbursement immediately after receipt of notification. If I fail to repay the excess reimbursement, the FEBB is authorized to: (1) offset the excess reimbursement against any other eligible expenses submitted for reimbursement (in accordance with applicable law); or (2) withhold the amount of the excess reimbursement from my pay (to the extent permitted by applicable law).
